15 majority of his life, but he has also served as the State Chairman of the Knights of Columbus  
16 Kidney Dialysis Program which provided four kidney dialysis machines to the state; and

17           WHEREAS, Arthur Paiva has earned the unqualified admiration and respect of one of the  
18 largest and most active fraternal organizations in the world, the Elks, as well as the citizenry of  
19 the City of Newport. His years of devoted service to the community are truly an inspiration to us
