RESOLVED, That a majority of all members elected to each house of the general 1 assembly voting therefor, the following amendment to the Constitution of the state be proposed to 2 3 the qualified electors of the state in accordance with the provisions of Article XIV of the 4 Constitution for their approval, to read as follows: ARTICLE 6 5 6 Section 23. Restriction on tolling. No act authorizing the imposition of tolls upon any 7 vehicle being operated on any bridge or roadway, other than those subject to tolls as of January 1, 2016, shall take effect until it has been approved by the majority of those electors voting in a 8 9 statewide referendum and by the majority of those electors voting in a referendum in the 10 municipality in which the proposed tolling would be allowed. 11 The secretary of state shall certify the results of the statewide referendum and the local 12 board of canvassers of the city or town where the tolling is to be allowed shall certify the results 13 of the local referendum to the secretary of state. and be it further 14 15 RESOLVED, That the said proposition of amendment shall be submitted to the electors for their approval or rejection at the next statewide general election. The voting places in the 16 several cities and towns shall be kept open during the hours required by law for voting therein for 17

RESOLVED, That the Secretary of State shall cause the said proposition of amendment

to be published as a part of the resolution in the newspapers of the state prior to the date of the said meetings of the said electors; and the said proposition shall be inserted in the warrants or notices to be issued previous to said meetings of the electors for the purpose of warning the town, ward, or district meetings, and said proposition shall be read by the town, ward, or district meetings to be held as aforesaid; and be it further

RESOLVED, That the town, ward, and district meetings to be held as aforesaid shall be warned, and the list of voters shall be canvassed and made up, and the said town, ward, and district meetings shall be conducted in the same manner as now provided by law for the town, ward, and district meetings for the elections of general officers of the state.
