It is enacted by the General Assembly as follows:

- SECTION 1. Chapter 42-61 of the General Laws entitled "State Lottery" is hereby
  amended by adding thereto the following section:

#### 42-61-19. Instant ticket scratch off game pilot program.

- 4 (a)(1) The director shall establish and is hereby authorized to promulgate rules and
- 5 regulations necessary to create an instant ticket scratch off game pilot program for the purposes of

6 <u>benefiting Rhode Island veterans and dependents of qualified service members.</u>

- 7 (2) The instant ticket scratch off game pilot program shall expire on December 31, 2018,
- 8 and instant ticket scratch off game pilot program shall be made available for sale during the
- 9 <u>following months:</u>

- 10 (i) May to honor Memorial Day.
- 11 (ii) November to honor Veterans' Day; and
- 12 (b) Instant ticket scratch off game pilot program restricted receipt account. The director

13 shall deposit all profits received from the sale of tickets pursuant to this section into a restricted

- 14 receipt account to support Rhode Island veterans and dependents of qualified service members.
- 15 Funds deposited pursuant to this section shall be distributed in accordance with procedures
- 16 adopted by the division and the office of veterans' affairs.
- 17 (c) Funds remaining unspent following the expiration of the instant ticket scratch off
- 18 game pilot program shall remain in the restricted receipt account and shall not revert to the
- 19 general fund.

- (d) On or before December 31, 2018, the director of the state lottery shall submit to the
  governor, the speaker of the house, and the president of the senate recommendations as to the
  continuation of this section and unless extended the provisions of this section shall cease on
  December 31, 2018.
  SECTION 2. This act shall take effect upon passage and shall expire on December 31,
- 6 2018.
