RELATING TO CRIMINAL OFFENSES-ASSAULTS

It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 11-5 of the General Laws entitled "Assaults" is hereby amended by
- 2 adding thereto the following section:

3 <u>11-5-18. Assaults on dwarfs or little people.</u>

- 4 (a) Definitions. As used in this chapter:
- 5 (1) "Disproportionate dwarf" means any person who has one or more body parts being
- 6 relatively large or small in comparison to those of an average sized adult.
- 7 (2) "Dwarf" or "little person" means any individual who is short in stature resulting from
- 8 <u>a medical condition caused by slow growth and who is less than four feet ten inches (4' 10") in</u>
- 9 <u>height.</u> "Dwarf" does not include any person who is short in stature, but whose height is inherited
- 10 and not a result of a medical condition.
- 11 (3) "Proportionate dwarf" means any person who has a body that appears normally
- 12 proportioned but is unusually small.
- 13 (4) "Serious bodily injury" means physical injury that:
- 14 (i) Creates a substantial risk of death and/or serious disfigurement;
- 15 (ii) Causes protracted loss or impairment of the function of any body part, member or
- 16 <u>organ; or</u>
- 17 (iii) Causes serious permanent disfigurement.
- 18 (b) Any person who shall knowingly and willfully commit an assault or battery, or both,
- 19 upon a dwarf, a disproportionate dwarf or a proportionate dwarf, resulting in bodily injury, shall

- 1 <u>be deemed to have committed a felony and shall be imprisoned up to three (3) years or be fined</u>
- 2 not exceeding one thousand five hundred dollars (\$1,500), or both.
- 3 (c) Any person who shall knowingly and willfully commit an assault or battery, or both,
- 4 upon a dwarf, a disproportionate dwarf or a proportionate dwarf, resulting in serious bodily
- 5 injury, shall be deemed to have committed a felony and shall be imprisoned up to twenty (20)
- 6 years or be fined not exceeding five thousand dollars (\$5,000), or both.
- 7 SECTION 2. This act shall take effect upon passage.

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

AN ACT

RELATING TO CRIMINAL OFFENSES-ASSAULTS

1 This act would make an assault or battery upon a dwarf resulting in bodily injury a felony

2 and would be punishable by up to three (3) years imprisonment and an assault resulting in serious

3 bodily injury punishable by up to twenty (20) years imprisonment.

4 This act would take effect upon passage.
