RELATING TO ANIMALS AND ANIMAL HUSBANDRY -- LIVESTOCK WELFARE AND CARE STANDARDS ADVISORY COUNCIL

It is enacted by the General Assembly as follows:

- 1 SECTION 1. Section 4-26-5 of the General Laws in Chapter 4-26 entitled "The Rhode
- 2 Island Livestock Welfare and Care Standards Advisory Council Act of 2012" is hereby amended
- 3 to read as follows:
- 4 **4-26-5. Duties of the council.**
- 5 The council shall support and work collaboratively with the department as follows:
- 6 (1) Review and evaluate laws and rules of the state applicable to the care and handling of
- 7 livestock as defined in subdivision 4-26-3(6) including, but not limited to:
- 8 (i) The overall health and welfare of livestock species;
- 9 (ii) Agricultural operation best management practices;
- 10 (iii) Biosecurity and disease prevention;
- 11 (iv) Humane transport and slaughter practices; and
- 12 (v) Any other matters the council considers necessary for the proper care and well being
- 13 of livestock animals in the state.
- 14 (2) Respond to requests from the legislature for information and comments on proposed
- 15 legislation;
- 16 (3) Issue recommendations necessary to achieve these goals;
- 17 (4) Submit policy recommendations to the director and general assembly on any of the
- 18 subject matter set forth under subdivision (ii) of this subsection-;

- 1 (5)(i) Conduct public hearings on any bill introduced in the general assembly prior to its
- 2 passage provided the bill involves the safety, health and humane environment of livestock; and
- 3 (ii) Present its recommendations to the general assembly explaining the reasons for its
- 4 recommendations at all hearings held with regard to the legislation conducted by any committee
- 5 of the general assembly.
- 6 SECTION 2. This act shall take effect upon passage.
