RELATING TO MOTOR AND OTHER VEHICLES -- REGISTRATION OF VEHICLES --  
SPECIAL PLATE FOR MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 31-3 of the General Laws entitled "Registration of Vehicles" is  
2 hereby amended by adding thereto the following section:

3 **31-3-117. Special plate for MASONIC GRAND LODGE CHARITIES OF RHODE**  
4 **ISLAND.**

5 (a) The administrator of the division of motor vehicles is empowered to make available  
6 special motor vehicle registration plates for the not-for-profit, 501(c)(3) Rhode Island  
7 Corporation, MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND. The plates shall  
8 be designed to reference MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND.

9 (b) The special plate shall be displayed upon the same registration number assigned to the  
10 vehicle for which it was issued, and shall be used in place of and in the same manner as the  
11 registration plates issued to the vehicle. The original registration plates for the vehicle shall be  
12 removed from the vehicle and returned to the division of motor vehicles. The registration  
13 certificate for the plates shall be carried in the vehicle, in accordance with § 31-3-9. The  
14 registration certificate shall be in effect for the special plate.

15 (c) MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND motor vehicle  
16 plates shall be the same size as regular motor vehicle plates, and shall be designed by the  
17 MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND in conjunction with the  
18 division of motor vehicles, with the design approved by the Rhode Island state police.

1           (d) MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND plates shall be  
2 subject to a minimum pre-paid order of at least five hundred (500) sets of plates per plate type  
3 (i.e. passenger, commercial, etc.). MASONIC GRAND LODGE CHARITIES OF RHODE  
4 ISLAND plates shall not be issued unless the minimum order(s) requirements are met. The initial  
5 order will be handled by the MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND,  
6 and shall not be submitted to the division of motor vehicles for production until the minimum  
7 order(s) have been met, and the proper paperwork submitted to the division.

8           (e) The administrator of the division of motor vehicles shall develop application forms,  
9 pre-payment procedures and any other procedures deemed necessary to carry out the purposes of  
10 this section.

11           (f) In addition to the regular prescribed motor vehicle registration fee, MASONIC  
12 GRAND LODGE CHARITIES OF RHODE ISLAND plates shall be subject to a forty dollar  
13 (\$40.00) issuance surcharge, to be allocated as follows: twenty dollars (\$20.00) shall be allocated  
14 to the general fund and the remaining twenty dollars (\$20.00) shall be distributed annually to the  
15 MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND to assist in its charitable work.  
16 (The distribution to the MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND shall  
17 be placed in a restricted account and shall be paid to the MASONIC GRAND LODGE  
18 CHARITIES OF RHODE ISLAND)

19           (g) MASONIC GRAND LODGE CHARITIES OF RHODE ISLAND will be required to  
20 submit an annual accounting report before such monies are distributed.

21           (h) There shall be no refunds for early cancellation of MASONIC GRAND LODGE  
22 CHARITIES OF RHODE ISLAND plates.

23           SECTION 2. This act shall take effect upon passage.
