12	surcharge fee assessed in accordance with § 8-15-11.
13	(c) Provided, that ten thirty dollars (\$10.00) (\$30.00) of the fee for the entry of every
14	petition, complaint or action shall be forwarded to Rhode Island Legal Services.
15	SECTION 2. This act shall take effect upon passage.
