It is enacted by the General Assembly as follows: 1 SECTION 1. Section 11-37.1-2 of the General Laws in Chapter 11-37.1 entitled "Sexual 2 Offender Registration and Community Notification" is hereby amended to read as follows: 3 11-37.1-2. Definitions. [Effective until July 1, 2019.] (a) "Aggravated offense" means, and includes, offenses involving sexual penetration of 4 5 victims of any age through the use of force, or the threat of use of force, or offenses involving 6 sexual penetration of victims who are fourteen (14) years of age or under. 7 (b) "Board", "board of review", or "sex offender board of review" means the sex offender 8 board of review appointed by the governor pursuant to § 11-37.1-6. 9 (c)(1) "Conviction" or "convicted" means, and includes, any instance where: 10 (i) A judgment of conviction has been entered against any person for any offense 11 specified in subsection (e) or (k), regardless of whether an appeal is pending; or 12 (ii) There has been a finding of guilty for any offense specified in subsection (e) or (k), regardless of whether an appeal is pending; or 13 14 (iii) There has been a plea of guilty or nolo contendere for any offense specified in 15 subsection (e) or (k), regardless of whether an appeal is pending; or (iv) There has been an admission of sufficient facts or a finding of delinquency for any 16

BY THE LEGISLATIVE COUNCIL
