Her condition was such that any further surgery would put her at great risk of becoming a quadriplegic. Yet even as her ambulation declined, she persisted in taking care of her 9 10 family and finding a way to move around, starting with a cane, then a walker, a scooter, and 11 finally a wheelchair in which she was dubbed "Mama Wheels"; and 12 WHEREAS, She was admired by many people for many things, including her beauty, 13 which was compared to Elizabeth Taylor, but what so many admired about her the most was her 14 refusal to give in to her illness. Despite her daily limitations, and the pain and discomfort that 15 were part of her everyday life, she persisted in loving and serving her family and being a part of 16 her community. From attending her grandchildren's many sporting activities, serving her family and friends her delicious meatballs, to getting her hair done at Butchie's or sunbathing in her 17 18 driveway, she lived life to the fullest.
