It is enacted by the General Assembly as follows:

SECTION 1. Section 42-66.3-4 of the General Laws in Chapter 42-66.3 entitled "Home
 and Community Care Services to the Elderly" is hereby amended to read as follows:

## 42-66.3-4. Persons eligible.

4 (a) To be eligible for this program the client must be determined, through a functional 5 assessment, to be in need of assistance with activities of daily living or and/or must meet a 6 required level of care as defined in rules and regulations promulgated by the department;

(b) Medicaid eligible individuals age sixty-five (65) or older of the state who meet the
financial guidelines of the Rhode Island medical assistance program, as defined in rules and
regulations promulgated by the department, shall be provided the services without charge; or

10 (c) Persons eligible for assistance under the provisions of this section, subject to the 11 annual appropriations deemed necessary by the general assembly to carry out the provisions of 12 this chapter, include: (1) any homebound unmarried resident or homebound married resident of 13 the state living separate and apart, who is ineligible for Medicaid, at least sixty-five (65) years of 14 age or, if under sixty-five (65) years of age, has a diagnosis of Alzheimer's disease or a related dementia confirmed by a licensed physician, ineligible for Medicaid, and whose income does not 15 exceed the income eligibility limits as defined by rules and regulations promulgated by the 16 department two hundred fifty percent (250%) of the federal poverty level; and (2) any married 17 18 resident of the state who is ineligible for Medicaid, at least sixty-five (65) years of age, ineligible

- 1 for Medicaid, or, if under sixty-five (65) years of age, has a diagnosis of Alzheimer's disease or a
- 2 related dementia confirmed by a licensed physician and whose income when combined with any
- 3 income of that person's spouse does not exceed two hundred fifty percent (250%) of the federal
- 4 <u>poverty level</u> the income eligibility limits as defined in rules and regulations promulgated by the
- 5 department. Persons who meet the eligibility requirement of this subsection shall be eligible for
- 6 the co-payment portion as set forth in § 42-66.3-5.

- SECTION 2. This act shall take effect upon passage.
