1 WHEREAS, The West Warwick Wizards Girls Volleyball Team entered the 2020-2021
2 season determined to avenge their heartbreaking playoff loss in the prior volleyball season and to
3 honor the memory of their 2019 teammate, Hannah Cyr, who tragically passed away in December
4 of 2020; and

5 WHEREAS, The Wizards entered the playoffs after an outstanding regular season in
6 which they finished in first place in the Division 2 West Volleyball standings and compiled a
