RELATING TO ALCOHOLIC BEVERAGES -- MANUFACTURING AND WHOLESALE LICENSES

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 3-6-15 of the General Laws in Chapter 3-6 entitled "Manufacturing
2 and Wholesale Licenses" is hereby amended to read as follows:

3 **3-6-15. Manufacturer's interest in business of wholesaler prohibited.**

4 (a) No manufacturer of ~~distilled spirits or wines whose principal place of manufacture is~~
5 ~~outside of this state~~ intoxicating beverages as defined in § 3-1-1 shall hold a wholesaler's license
6 issued under this title or shall have any interest in a wholesaler's license, either directly or
7 indirectly, as an owner or part owner, or through a subsidiary or affiliate, or by any officers,
8 directors, or employees of the manufacturer, or by stock ownership, interlocking directors,
9 trusteeship, loan, mortgage or by being a guarantor, endorser or surety of any obligation of a
10 wholesaler.

11 (b) Any manufacturer of intoxicating beverages as defined in § 3-1-1, who currently holds
12 a wholesaler's license issued under this title or shall have any interest in a wholesaler's license,
13 either directly or indirectly, as an owner or part owner, or through a subsidiary or affiliate, or by
14 any officers, directors, or employees of the manufacturer, or by stock ownership, interlocking
15 directors, trusteeship, loan, mortgage or by being a guarantor, endorser or surety of any obligation
16 of a wholesaler, as of the effective date of this act, shall be permitted to retain and renew their
17 current manufacturer's and wholesaler's licenses.

18 (c) Anyone who maintains both manufacturing and wholesaler licenses pursuant to the

1 [exception in subsection \(b\) of this section shall not be permitted to transfer the wholesaler license](#)
2 [to a third party.](#)

3 SECTION 2. This act shall take effect upon passage.
