It is enacted by the General Assembly as follows:

- 1 SECTION 1. Section 32-1-17 of the General Laws in Chapter 32-1 entitled "General
- Provisions" is hereby amended to read as follows: 2
- 3 32-1-17. Persons with disabilities.
- No fee shall be charged any person with a disability regardless of age, or to automobiles 4

transporting a non-driver with a disability, at any recreational facility owned and operated by the 5

state; provided, however, proper identification is presented as prescribed by the department of 6

7 environmental management. For the purpose of this section "person with a disability" shall mean

- 8 an individual who has a physical or mental impairment and is receiving:
- 9

(a) Social <u>Receiving social</u> security disability benefits (SSDI);

10 (b) Supplemental Receiving supplemental security income benefits (SSI); or

11 (c) Veterans <u>Receiving veterans</u> benefits and who shall be determined under applicable

12 federal law by the federal department of veterans' affairs to be one hundred percent (100%)

- 13 disabled through a service-connected disability-; or
- 14 (d) Determined by the executive office of health and human services, or its designee, to be
- 15 disabled for purposes of Medicaid eligibility.

16 For purpose of this section, "fees" shall include all fees for parking, admittance, or other 17 user fees for playing golf. The term "fees" shall not include licensing fees, camping fees, picnic 18 table fees, or specialized facility use fees, including, but not limited to, fees for the use of equestrian areas, performing arts centers, game fields, and mule shed. 19

SECTION 2. This act shall take effect upon passage.
