4 REVIEW AND PROVIDE RECOMMENDATIONS FOR POLICIES THAT DEAL WITH
5 NUMEROUS ECONOMIC AND SOCIAL SHORT-TERM RENTALS ISSUES" and as
6 extended and amended by Resolution No. 284 passed by the House of Representatives at its
