2	Fox, Jr., of Cranston. He was the beloved husband of Wendy Fox for 49 years; and
3	WHEREAS, Paul J. Fox, Jr., known to many as "PJ", was the son of the late Paul J. and
4	Marian E. Fox. He was a graduate of Our Lady of Providence and Providence College. Mr. Fox
5	was a hard-working man who had a long and distinguished professional career. His first position
6	was with his father, Paul J. Fox, Sr., with the family business, the PJ Fox Paper Company. Mr.
7	Fox eventually rose to the position of company President and later in his career, he worked in the
8	insurance industry and finally at the Internal Revenue Service; and
9	WHEREAS, Paul J. Fox, Jr., was a member of numerous professional, civic, and
10	religious organizations, including the Friendly Sons of St. Patrick and the Sons of Irish Kings. He
11	served with distinction as a former Commissioner of the Cranston Redevelopment Agency, and
12	also served as a member and Past President of the Rotary Club of Providence and was the first
13	President of the Board of the Genesis Center in Providence. He also received the Paul Harris
14	Award from the Rotary International. Mr. Fox was a lifelong communicant of St. Paul Church;

16	WHEREAS, Paul J. Fox first met the love of his life, Wendy Baltzer, when they were
17	fellow students at ES Rhodes Elementary School. They met again nearly two decades later, and
18	embarked on a wonderful and loving marriage for almost five decades that included raising their
19	five children in the Edgewood Neighborhood of Cranston; and
20	WHEREAS, In addition to his wife, Wendy, Paul J. Fox, Jr., leaves behind his children
