1	WHEREAS, The Leukemia & Lymphoma Society (LLS) is a 501(c)(3) charitable
2	organization, and is a global leader in the fight against blood cancer; and
3	WHEREAS, The noble mission of LLS is to ultimately "cure leukemia, lymphoma,
4	Hodgkin's disease and myeloma, and improve the quality of life of patients and their families";
5	and
6	WHEREAS, Leukemia is a cancer that affects the white blood cells in the body, starting
7	in the bone marrow, where the cells are produced, and eventually disrupts the normal production
8	of these cells; and
9	WHEREAS, There are many types of Leukemia, and the exact cause of this disease is
10	unknown. It can occur at any age, but it is more common in adults than children; and
11	WHEREAS, LLS supports and raises funding for "lifesaving blood cancer research
12	around the world, provides free information and support services, and is a voice for blood cancer
13	patients seeking access to quality, affordable, coordinated care"; and
14	WHEREAS, The Leukemia & Lymphoma Society's "Light The Night® Walk", to be
15	held on September 27, 2025, is a premier fundraising event established to help fund lifesaving
16	research, provide advocacy and support for blood cancer patients and their families, and raise
17	awareness and bring communities together to celebrate and commemorate lives touched by blood
18	cancer; and
19	WHEREAS, The "Light The Night® Walk", is an evening event, held in the City of

- 2 the darkness of cancer with lanterns of hope"; now, therefore be it
