JOINT RESOLUTION

TO APPROVE AND PUBLISH AND SUBMIT TO THE ELECTORS A PROPOSITION OF
AMENDMENT TO THE CONSTITUTION -- GREEN AMENDMENT

1 RESOLVED, That a majority of all members elected to each house of the general
2 assembly voting therefor, the following amendment to the Constitution of the state be proposed to
3 the qualified electors of the state in accordance with the provisions of Article XIV of the
4 Constitution, for their approval, and that it adds an additional section to Article 1, which is hereby
5 amended, effective January 1, 2027, to read as follows:

6 ARTICLE I

7 DECLARATION OF CERTAIN CONSTITUTIONAL RIGHTS AND PRINCIPLES

8 SECTION 25. Green amendment.

9 All people in the State of Rhode Island have an inherent, inalienable, indefeasible, and
10 self-executing right to clean air and water, healthy soil, a safe climate, and to the preservation of
11 the natural and healthful values of our environment. The state shall serve as trustee of the natural
12 resources of Rhode Island, and shall conserve, protect, and maintain these resources for the
13 benefit of all the people, including both present and future generations. The state shall not
14 infringe upon these rights and shall protect these rights and Rhode Island's natural resources
15 equitably for all people regardless of race, ethnicity, gender or socioeconomic status.

16 RESOLVED, That this proposition of amendment shall amend Article 1 as aforesaid; and
17 be it further

18 RESOLVED, That said proposition of amendment shall be submitted to the electors for
19 their approval or rejection at the next statewide general election. The voting places in the several

1 cities and towns shall be kept open during the hours required by law for voting therein for general
2 officers of the state; and be it further

3 RESOLVED, That the secretary of state shall cause the said proposition of amendments
4 to be published as a part of this resolution in the newspapers of the state prior to the date of the
5 said meetings of the said electors; and the said proposition shall be inserted in the warrants or
6 notices to be issued previous to said meetings of the electors for the purpose of warning the town,
7 ward, or district meetings, and said proposition shall be read by the town, ward, or district
8 meetings to be held as aforesaid; and be it further

9 RESOLVED, That the town, ward, and district meetings to be held aforesaid shall be
10 warned, and the list of voters shall be canvassed and made up, and the said town, ward, and
11 district meetings shall be conducted in the same manner as now provided by law for the town,
12 ward, and district meetings for the election of general officers of the state.
