SECTION 3. This act shall take effect upon passage and shall apply to any accident occurring after the effective date of this act, and shall apply with respect to all accidents involving a for hire motor vehicle or truck subject to a written rental or lease agreement throughout the entire term of said agreement or thirty-nine (39) months, whichever is shorter, provided that:

- (i) the accident occurred after the passage of this act, and
- (ii) the agreement was in effect at the time of passage of this act, or the agreement is entered into before 11:59 p.m. on June ~~30, 2005~~ 1, 2006.

SECTION 2. Section 4 of chapter 115 of the 2003 Public Laws entitled "An Act Relating to Motor and Other Vehicles," as amended by chapters 219 and 224 of the 2004 Public Laws is hereby further amended to read as follows:

SECTION 4. Except as provided in Section 3 of this act, the amendments contained in Sections 1 and 2 of this act shall be repealed on ~~July 1, 2005~~ June 2, 2006.

Any written rental or lease agreement entered into on or after ~~July 1, 2005~~ June 2, 2006 shall be subject to the provisions of sections 31-33-5 and 31-34-4 in effect prior to the passage of this act.

SECTION 3. This act shall take effect upon passage and shall apply to any accident occurring after the effective date of this act, and shall apply with respect to all accidents involving a for hire motor vehicle or truck subject to a written rental or lease agreement throughout the entire term of said agreement or thirty-nine (39) months, whichever is shorter; provided that:

- (i) the accident occurred after the passage of this act; and
- (ii) the agreement was in effect at the time of passage of this act, or the agreement is entered into before 11:59 p.m. on June ~~30, 2005~~ 1, 2006.

[Effective until June 2, 2006.] -- (a) Except as provided in subsections (c), (d) and (e) below, whenever any motor vehicle shall be used, operated, or caused to be operated upon any public highway of this state with the consent of the owner, lessee, or bailee, expressed or implied, the driver of it, if other than the owner, lessee, or bailee, shall in the case of an accident be deemed to be the agent of the owner, lessee, or bailee, of the motor vehicle unless the driver shall have furnished proof of financial responsibility in the amount set forth in chapter 32 of this title, prior to the accident.

(b) For the purposes of this section, the term "owner" includes any person, firm, copartnership, association, or corporation having the lawful possession or control of a motor vehicle under a written sale agreement.

(c) Notwithstanding the provisions of subsections (a) and (b) immediately above, the liability of a lessor of a short-term rental motor vehicle or truck will be subject to a limit of two hundred fifty thousand dollars (\$250,000) for bodily injury to or the death of one person in any one accident, and subject to the limit for one person, to a limit of five hundred thousand dollars (\$500,000) for bodily injury to or the death of two (2) or more persons in any one accident, and a limit of twenty-five thousand dollars (\$25,000) because of injury to or destruction of property of others in any one accident.

(d) Notwithstanding the provisions of subsections (a) and (b) above, if a person, firm, copartnership, association, or corporation:

(1) (A) Holds title to a long-term lease motor vehicle or truck as lessor; or

(B) Is the successor to or assignee of the lessor's interest in a long-term lease motor vehicle or truck and holds title thereto; and

(2) At the time of the accident, the lessee holds valid motor vehicle liability insurance on the vehicle which contains limits in an amount equal to or greater than one hundred thousand dollars (\$100,000) for bodily injuries to any one person, three hundred thousand dollars (\$300,000) for bodily injuries in any one accident, and fifty thousand dollars (\$50,000) for damage to property of others in any accident or a combined single limit of three hundred thousand dollars (\$300,000) or greater; then the lessee shall, for the purposes of this section, be the "owner" and the title holder will neither be the "owner" for the purposes of this section nor otherwise responsible under this section.

(e) Notwithstanding subsections (a) and (b) above, if a person, firm, copartnership, association, or corporation:

(1) (A) Holds title to a long-term lease motor vehicle or truck as lessor; or

(B) Is the successor to or assignee of the lessor's interest in a long-term lease motor vehicle or truck and holds title thereto; and

(2) At the time of the accident, the lessee does not hold valid motor vehicle liability insurance on the vehicle which contains limits in an amount equal to or greater than one hundred thousand dollars (\$100,000) for bodily injuries to any one person, three hundred thousand dollars (\$300,000) for bodily injuries in any one accident, and fifty thousand dollars (\$50,000) for damage to property of others in any accident or a combined single limit of three hundred thousand dollars (\$300,000) or greater; then the title holder's financial responsibility as "owner"

of the motor vehicle or truck will be limited to the difference between: (1) the motor vehicle liability insurance limit actually maintained by the lessee at the time of the accident; and (2) one hundred thousand dollars (\$100,000) for bodily injuries to any one person, three hundred thousand dollars (\$300,000) for bodily injuries in any one accident, and fifty thousand dollars (\$50,000) for damage to property of others in any accident.

(f) "Lessor" includes any entity in the business of renting and/or leasing motor vehicles pursuant to a written rental and/or lease agreement.

(g) "Short-term rental motor vehicle or truck" means, for the purposes of this section, a motor vehicle or truck that is leased by a lessor, pursuant to a written lease or rental agreement, for an initially agreed-upon term of less than twelve (12) months.

(h) "Long-term lease motor vehicle or truck" means, for the purposes of this section, a motor vehicle or truck that is leased by a lessor, pursuant to a written lease or rental agreement, for an initially agreed-upon term of twelve (12) months or longer.

(i) Sunset provision: The amendments contained in chapter 115 of the 2003 public laws shall be repealed ~~July 1, 2005~~ June 2, 2006 and shall apply to any accident occurring after July 7, 2003, and shall apply with respect to all accidents involving a for hire motor vehicle or truck subject to a written rental or lease agreement throughout the entire term of said agreement or thirty-nine (39) months, whichever is shorter, provided that:

[Effective until June 2, 2006.] -- (a) Except as provided below, any owner of a for hire motor vehicle or truck who has given proof of financial responsibility under this chapter or who in violation of this chapter has failed to give proof of financial responsibility, shall be jointly and severally liable with any person operating the vehicle for any damages caused by the negligence of any person operating the vehicle by or with the permission of the owner.

(b) The liability of a lessor of a short-term rental motor vehicle or truck under this section shall be subject to a limit of two hundred fifty thousand dollars (\$250,000) for bodily injury to or the death of one person, and subject to the limit for one person, to a limit of five hundred thousand dollars (\$500,000) for bodily injury to or the death of two or more persons in any one accident, and a limit of twenty-five thousand dollars (\$25,000) because of injury to or destruction of property of others in any one accident.

(c) With respect to any long-term lease motor vehicle or truck:

(1) The owner and/or lessor (and/or its successors or assignees) of a long term lease motor vehicle or truck who is not the operator of the vehicle at the time of an accident shall not be jointly and severally liable with the operator and/or the lessee of the vehicle for any damages caused by the negligence of any person operating the vehicle if, at the time of the accident, the lessee has valid motor vehicle liability insurance which contains limits in an amount equal to or greater than one hundred thousand dollars (\$100,000) for bodily injuries to any one person in any one accident, three hundred thousand dollars (\$300,000) for bodily injuries in any one accident, and fifty thousand dollars (\$50,000) for damage to property of others in any accident or a combined single limit of three hundred thousand dollars (\$300,000) or greater;

(2) If the lessee of a long-term lease motor vehicle or truck does not have insurance in the amounts set forth in subsection (c)(1) above, then the liability of the owner and/or lessor (and/or its successors or assignees) of a long-term lease motor vehicle or truck shall not exceed the difference between: (1) the motor vehicle liability insurance limits actually maintained by the lessee of the long-term lease motor vehicle or truck at the time of the accident; and (2) one hundred thousand dollars (\$100,000) for bodily injuries to any one person, three hundred thousand dollars (\$300,000) for bodily injuries in any one accident, and fifty thousand dollars (\$50,000) for damage to property of others in any accident.

(d) Nothing in this section shall be construed to prevent an owner who has furnished proof of financial responsibility or any person operating the vehicle from making defense in an action upon the ground of comparative negligence to the extent to which the defense is allowed in other cases.

(e) Notwithstanding the provisions of subsection (a) of this section, or any provisions contained under title 31 to the contrary, the operator's valid collectable liability or self-insurance providing coverage or liability protection for any third party liability claims shall be primary, and the valid and collectable liability or self-insurance providing coverage or liability protection for any third-party liability claims for the owner and/or lessor arising out of the operation of the vehicle shall be excess. This shall be stated in ten (10) point type on the face of any short-term rental agreement.

(f) "Lessor" includes any entity in the business of renting and/or leasing motor vehicles pursuant to a written rental and/or lease agreement.

(g) "Short-term rental motor vehicle or truck" means, for the purposes of this section, a motor vehicle or truck that is leased by a lessor, pursuant to a written lease or rental agreement, for an initially agreed-upon term of less than twelve (12) months.

(h) "Long-term lease motor vehicle or truck" means, for the purposes of this section, a motor vehicle or truck that is leased by a lessor, pursuant to a written lease or rental agreement, for an initially agreed-upon term of twelve (12) months or longer.

I hereby move to amend 2005 -- H 5027 SUBSTITUTE B, as amended, entitled "AN ACT RELATING TO COMMERCIAL LAW -- UNFAIR SALES PRACTICES", as follows:

1. By deleting all of the language following the enactment clause and inserting in place thereof the following:

"SECTION 1. Section 6-13-12 of the General Laws in Chapter 6-13 entitled "Unfair Sales Practices" is hereby amended to read as follows:

6-13-12. Sales of gift certificates. -- "Gift certificate" means a record evidencing a promise, made for monetary consideration, by the seller or issuer for the record that goods or services will be provided to the owner of the record to the value shown in the record and includes, but is not limited to, a record that contains a microprocessor chip, magnetic strip or other means of storage of information that is pre-funded and for which the value is decremented upon each use, a gift card, an electronic gift card, stored-value card or certificate, a store card, a prepaid telephone card used solely for a nonwireless, long distance telephone service, or a similar record or card. Any person, firm, or corporation that sells gift certificates for any product or merchandise sold by the person, firm, or corporation, shall be required to record the sales and keep an accurate and complete record of each gift certificate sold. The record shall include the date of sale, the full value of the certificate, the identification number assigned by the retailer to the certificate, and the state in which the sale of the certificate took place. The retailer shall further be required to give to the purchaser of gift certificates exceeding fifty dollars (\$50.00) a written and numbered receipt evidencing the sale of the certificate. It shall be unlawful for any person, firm, or corporation of any kind to charge additional monthly or annual service or maintenance fees on gift certificates or to limit the time for the redemption of a gift certificate or to place an expiration date upon the gift certificate. No gift certificate or any agreement with respect to such gift certificate may contain language suggesting that an expiration date may apply to the gift certificate. Any person, firm, or corporation that shall violate the provisions of this section shall be punished by a fine of not more than two hundred dollars (\$200). Due to the unlimited redemption period, the division of taxation shall not escheat the funds paid for those unredeemed gift certificates. Any unused portion of a redeemed gift certificate shall be afforded to the consumer by reissuing the gift certificate for the unused amount or providing cash where the balance due the consumer is less than one dollar (\$1.00). This section shall not apply to the following:

~~(a) General use prepaid cards issued by a third party prepaid card issuer which shall mean plastic cards or other electronic payment devices which are: (1) usable at multiple, unaffiliated, merchants or service providers and/or at automatic teller machines ("ATMs"); (2) issued in a requested amount which amount may be, at the option of the issuer, increased to value or reloaded if requested by the holder; (3) purchased and/or loaded on a prepaid basis by a consumer and shall not include debit cards linked to a deposit account, or cards purchased by a business entity; and (4) honored upon presentation by merchants for goods or services, or at ATMs.~~

(b) (a) Gift certificates that are distributed to a consumer pursuant to an awards, loyalty or promotional program without any money or other thing of value being given in exchange for the gift certificate by the consumer. Any restrictions or limitations which such gift certificates may be subject to must be disclosed to the consumer, in writing, at the time the gift certificates are distributed to the consumer.

(c) (b) ~~Cards used for prepaid wireless telephone services will not be subject to this section until January 1, 2006. Prepaid wireless telephone service or prepaid wireless telephone card.~~ "Prepaid wireless telephone service" means wireless telephone service that is activated in advance by payment for a finite dollar amount of service or for a finite set of minutes that terminate either upon use by a customer and delivery by the wireless provider of an agreed-upon amount of service corresponding to the total dollar amount paid in advance or within a certain period of time following the initial purchase or activation, unless additional payments are made. SECTION 2. This act shall take effect upon passage."

I hereby move to amend 2005 -- H 6530 SUBSTITUTE A, entitled "AN ACT RELATING TO INSURANCE -- WORKERS' COMPENSATION INSURANCE FUND", as follows:

By striking all of the language following the enactment clause and inserting in place thereof the following language:

"SECTION 1. Section 20 of Chapter 410 of the 2003 Public Laws entitled "An Act Relating to Insurance – Workers' Compensation Fund" is hereby amended to read as follows:

SECTION 20. Reserves – Premium to surplus ratio – Insolvency fund. – (a) The fund shall maintain a ratio of premiums on policies written to surplus of not more than three (3) to one (1), or any greater or lesser ratio that the director of the department of business regulation deems appropriate. In determining the ratio, the director may at all times consider the net present value of future capital assessment amounts as current surplus. To facilitate the ongoing oversight of the fund, the fund shall submit to the department of business regulation quarterly and annual statements in the format and scope specified in section 27-12-2.

(b) The fund shall ~~not participate in, or be subject to,~~ the insurers' insolvency fund established under section 27-34-6.

(c) In the event of the liquidation of the fund pursuant to the Insurers' Rehabilitation and Liquidation Act, chapter 14.3 of title 27, the fund's policyholders, in their capacity as owners of the fund, shall have no distributive claims under section 27-14.3-46(8) to the liquidation estate of the fund and, upon satisfaction of any other class 1 through class 7 claims under section 27-14.3-46, the insurance commissioner, as receiver, shall distribute the residual, if any, of the fund's liquidation estate to the director of the department of labor and training; provided, that in no event shall these provisions affect the validity or priority of: (1) any claims arising from and within the coverage of any policies of the fund; or (2) claims of the director of the department of labor and training to repayment of the term note of the fund issued pursuant to section 18.

SECTION 2. There shall be established a joint study commission comprised of ten (10) members, five (5) from the house of representatives, four (4) from the majority party, to be appointed by the speaker of the house and one from the minority party to be appointed by the house minority leader; and five (5) from the senate, four (4) from the majority party, to be appointed by the president of the senate and one from the minority party to be appointed by the senate minority leader. The commission shall study and examine the stabilization, fiscal health, and proper functioning of the Rhode Island Workers' Compensation system and the Rhode Island Insurers' Insolvency Fund. Upon the passage of this act, the members of the commission shall meet at the call of the speaker of the house and the president of the senate. The speaker of the house and the president of the senate shall select co-chairpersons from among the members. Vacancies shall be filled in like manner as the original appointment. The committee shall file its report to the general assembly by April 1, 2006.

SECTION 3. This act shall take effect upon passage."
