Madam President:

I hereby move to amend 2012 -- S 2277 SUBSTITUTE A, entitled "AN ACT RELATING TO HEALTH AND SAFETY - ENVIRONMENTAL CLEAN UP OBJECTIVES FOR SCHOOLS", as follows:

1. On page 1, by deleting all of the language on lines 12 through 15, inclusive, and inserting, in lieu thereof, the following language:

“on any portion of a parcel of property for which, upon occupancy, there exists an ongoing potential for hazardous materials and/or petroleum to migrate as vapors or gases into the building from the subsurface of the parcel of property, including any potential failure of engineered remedies to address said vapors or gases.”
